2. Deed of Land transferring part of Lot 13 from Samuel Y. Shantz to Jacob E. and Esther Shantz, July 7, 1883. The size of the transfer was 121 acres and the cost was \$5,200. While the description of the details concerning location are difficult to read and incomplete on this copy, this land presumably became the farm of Jacob E. and Lydia Shantz, later becoming the farm of Benjamin B. and Myra Shantz.
